The discussion covered the implementation of MIGREC as a project, practices that it should apply with a view to improving its sustainability prospects, and its research interests and policy assessment particularly from the perspective of the Western Balkans.





Open Forum: "What do European University Alliances add to internationalization?" with Prof. Dr. Florian J. Schweigert



On May 11, 2023, the Department of Political Science and International Relations held an open forum on the topic "What do European University Alliances add to internationalization?" with the special guest Prof. Dr. Florian J. Schweigert, who serves as vice President for the Internationalization and Fundraising speaker of the EDUC Alliance.

The forum aimed at presenting and explaining some overview and insights on how cooperation among European universities functions, and how both member and non-member states from the EU can benefit from this cooperation. Prof. Dr. Schweigert went on explaining the main targets these university alliances aim to achieve: the first, is promoting common European values and strengthening European identity by educating a new generation of Europeans able to work together across borders; and the second, is increasing the quality and competitiveness of the European education, research and innovation landscape. Therefore, young European students will not only be able to meet and overcome current challenges of their region, but also global ones.

The EDUC alliance works on the establishment of a novel, in-depth quality of transnational cooperation that works towards systemic, structural and sustainable change in the participating (and other) universities. Through creating new mobility formats, this alliance can establish knowledge transfer between regional ecosystems and academia. "In this way, not only a strong research and innovation dimension is created, but also a road of lifelong learning for all involved in the process" states Prof. Dr. Schweigert.

They emphasized the importance of working with one's abilities and values, and that of a strong self-esteem. These two examples served as inspiration for our students.




"The credibility of 2023 local elections in Albania" Debate

The aim of this conference was to identify and provide solutions, processes and elements that embody EU values and facilitate policy making at the EU level, with the goal of fostering a system that not only empowers citizens but also promotes governance and openness at the This International conference was comprised of multiple panels, where each one was characterized of specific topics, this in turn gave the floor for professors and graduate students to present their topics.

The opening of the conference began with the scientific debates and it's started with the scientific debates, after the session ended, it gave the floor to the panels.

On the third panel titled "The role of public policies and civil initiatives in the European integration process" Dr. Jubiana Vila, Head of the center for European Studies at Epoka University, alongside with the graduate student Iris Buciqi presented their topic "Civil Society Organizations and Regional Collaboration in Western Balkans".

In the fifth panel titled "Management of interethnic relations and community security in the European integration process", Dr. Reina Zenelai, Head of the Department for Political Science and International Relations at Epoka University, alongside with the graduate student Dragana Kurti presented the topic "Dynamics of Regionalism in Western Balkans: A quest for Regional Identity". On the third panel titled "The role of public policies and civil initiatives in the European integration process" Dr. Jubiana Vila, Head of the center for European Studies at Epoka University, alongside with the graduate student Iris Buciqi presented their topic "Civil Society Organizations and Regional Collaboration in Western Balkans".

On the same panel graduate students of Epoka University, Shysti Bushati and Ingrit Melani Presented their topics which were titled "A shift in IR approach after Ukraine war: Remilitarization of Europe, an interpretation through the realist lens" and "How are populism and Euroscepticism linked with left and right ideologies? The case of FIDESZ and Podemos."

The Legitimacy of New Regionalism in the European Integration Process

CEEPUS Lecture: "Hungary as an alternative role model? Domestic politics, the EU, and external relations", with Dr. Christina Griessler



On May 31, 2023, the Department of Political Science and International Relations at held a CEEPUS lecture at Epoka University with the topic "Hungary as an alternative role model? Domestic politics, the EU, and external relations", which was presented by Dr. Christina Griessler, Chair of Comparative Politics, Andrássy Universität Budapest, Hungary. This lecture was followed by Dr. Reina Zenelaj, head of the Department of Political Sciences and International, Dr. Avdi Smajljaj, M.Sc. Dea Bashkurti and Mr. Aldo Bumci, Member of the Parliament of the Republic of Albania.



Dr. Christina began by giving a brief historical overview of Hungary after World War II until the collapse of communism, and the transitional period of the country. Dr. Christina also mentioned the process of transition and the challenges with the current political and populist regime under the leadership of Viktor Orbán and his party FIDESZ from 2010 and 2023. The focus in this particular time was the problems created by FIDESZ, such as the abuse of the electoral systems, constant changes in the constitution, restrictions of civil society, decrease of the rule of law, media centralization. She mentioned how Orbán's rhetoric and narratives frame Hungary as a populist democracy, furthermore mentioning Hungary's critical stance on stricter EU conditionality and the rule of law. Dr. Christina concluded by stating the critic's remarks on how Hungary's democratic system has been weakened, impacting check and balances and targeting NGOs focused on the rule of law.

"Constitutions and the constitutional amendment process" with Prof. L. Marvin Overby

On May 30, 2023, the department of Law and the department of Political Science and International Relations welcomed Prof. L. Marvin Overby, PhD, Director of the School of Public Affairs of Pennsylvania State University. Prof. Overby held an open discussion regarding the US Constitution, its functions, amendments and history, while also not lacking a comprehensive understanding of other constitutions, such as the Albanian or the Indian one.

Prof. Overby went on explaining how the US constitution was formed and how it remains a core stone of the American modern state. He mentioned how, interestingly, the US constitution is one of the shortest written constitutions. Another important point mentioned was the abundance of changed constitutions in the last 20 years, 800 national ones, which, according to the professor, poses challenges regarding the legitimacy of such foundations.

Prof. Overby mentioned that, despite the US constitution serving as a blueprint, perhaps it is not the most adequate model to be followed, due to issues it has regarding full faith and credit, assumption of debt or ratification.

Secondly, Prof. Overby, held a discussion on the process of amendment. There exists an impressive array of different amendment processes: some countries set high bars and pose difficulties for changes, and some set low bars. High bars pertain on supermajorities, or vetoes, and low bars on simple majorities. Prof Overby highlighted the advantages and disadvantages of amendments, as well as the stakeholders who are involved in the process.



Public Panel: "The Western Balkans on the Road to the European Union" by the Center for European Studies



On June 1st, 2023, the Center for European Studies organized the Public Panel "The Western Balkans on the Road to the European Union." The event was organized within the framework of the Jean Monnet Module Project "EU Integration of Western Balkans: Patterns and Issues" (WB-EU Path Module) led by EPOKA University and co-funded by the Erasmus+ Program of the EU. The panel aimed to bring together academics and policymakers to discuss and share their perspectives on the Western Balkan countries' EU integration dynamics, issues, and challenges, with a particular focus on the EU integration path of Albania and Serbia.



Chaired by Dr. Jubjana Vila, leader of the WB-EUPath Jean Monnet Module, the panel included Assoc. Prof. Dr. Lisen Bashkurti, Dean of the Faculty of Law and Social Sciences at EPOKA University; Dr. Ivana Radic Milosavljevic, member of the Faculty of Political Sciences at the University of Belgrade; Mr. Aldo Bumçi, a former member of the Parliament of the Republic of Albania; Dr. Christina Griessler, Chair of Comparative Politics at Andrássy Universität Budapest; and Prof. L. Marvin Overby, Director of the School of Public Affairs at Penn State Harrisburg.

2nd Graduate Seminar by the Center for European Studies: "Serbia's EU Integration Issues and Challenges", with Dr. Ivana Radic Milosavljevic

On 2nd June, 2023, the Department of Political Science and International Relations organized within the framework of the Jean Monnet Module Project "EU integration of Western Balkans: Patterns and Issues" a seminar titled "Serbia's Issues and Challenges", which was presented by Dr. Ivana Radic Milosavljevic, of the Faculty of Political Sciences from the University of Belgrade, Serbia. This seminar was followed by Dr. Jubjana Vila, Head of the Center for European Studies and Dr. Mirela Alhasani, as well as the graduate students of Epoka University.

Dr. Ivana began a short historical introduction from Serbia's conflict at the end of the nineties, then she proceeded by giving a more detailed elaboration on the country's pursuit of EU accession and its contemporary political climate, on also stressing the issues and challenges that the country is currently facing. Dr. Ivana mentioned how Serbia is actively pursuing EU membership, progress has been made, including the opening of negotiations and adoption of new methodologies.

However, she mentioned that there are e number of obstacles or challenges that Serbia has to resolve, such as its critical stance on Kosovo's independence, trouble with the war crimes committed during the Milosevic era to include also the difficulties extraditing war crime suspects. Dr. Ivana added that other problematic aspects such as the rule of law and public opinion's negative perception of the EU are also key issues that the country must address.

And lastly Dr. Ivana concluded by saying that overcoming these difficulties and garnering more support are critical to Serbia's successful path toward EU membership.
